Application Notes:	 The supplier is only responsible for the kit itself, but not for the samples consumed during the assay. The user should calculate the possible amount of the samples used in the whole test. Please reserve sufficient samples in advance. Samples to be used within 5 days may be stored at 2-8°C, otherwise samples must be stored at -20°C (≤ 1 month) or -80°C (≤ 2 months) to avoid loss of bioactivity and contamination. Grossly hemolyzed samples are not suitable for use in this assay. If the samples are not indicated in the manual, a preliminary experiment to determine the validity of the kit is necessary. Please predict the concentration before assaying. If values for these are not within the range of the standard curve, users must determine the optimal sample dilutions for their particular experiments. Tissue or cell extraction samples prepared by chemical lysis buffer may cause unexpected

	 ELISA results due to the impacts of certain chemicals. Owing to the possibility of mismatching between antigens from another resource and antibodies used in this supplier's kits (e.g., antibody targets conformational epitope rather than linear epitope), some native or recombinant proteins from other manufacturers may not be recognized by this supplier's products. 	mercaptoethanol (2-ME) or any other poisonous materials. For the sandwich method kits, the
	sample diluent, antibody diluent, enzyme diluent and standard all contain BSA.

Protocol:	Antibody specific for ARRB2 has been pre-coated onto a microplate. Standards and samples
	are pipetted into the wells and any ARRB2 present is bound by the immobilized antibody. After
	removing any unbound substances, a biotin-conjugated antibody specific for ARRB2 is added to
	the wells. After washing, avidin conjugated Horseradish Peroxidase (HRP) is added to the wells.

	Following a wash to remove any unbound avidin-enzyme reagent, a substrate solution is addec
	to the wells and color develops in proportion to the amount of ARRB2 bound in the initial step.
	The color development is stopped and the intensity of the color is measured.
Reagent Preparation:	 Biotin-antibody (1×) - Centrifuge the vial before opening. Biotin-antibody requires a 100-fold dilution. The suggested dilution is 10µL of Biotin-antibody + 990µL of Biotin-antibody Diluent. HRP-avidin (1×) - Centrifuge the vial before opening. HRP-avidin requires a 100-fold dilution. The suggested dilution is 10µL of HRP-avidin + 990µ of HRP-avidin Diluent. Wash Buffer (1×) - If crystals have formed in the concentrate, warm up to room temperature and mix gently until the crystals have completely dissolved. Dilute 20mL of Wash Buffer (1×). Standard - Centrifuge the standard vial at 6000-10000rpm for 30s. Reconstitute the Standard with 1ml of Sample Diluent. Do not substitute other diluents. This reconstitution produces a stock solution. Mix the standard to ensure complete reconstitutior and allow the standard to sit for a minimum of 15 minutes with gentle agitation prior to making dilutions. Pipette 250µL of Sample Diluent into each tube. Use the stock solution to produce a 2-fold dilution series. Mix each tube thoroughly before the next transfer. The undiluted Standard serves as the high standard. Sample Diluent serves as the zero standard (0ng/mL).
	 Note: Kindly use graduated containers to prepare the reagent. Please don't prepare the reagent directly in the Diluent vials provided in the kit. Bring all reagents to room temperature (18-25°C) before use for 30 min. Prepare fresh standard for each assay. Use within 4 hours and discard after use. Making serial dilution in the wells directly is not permitted. Please carefully reconstitute Standards according to the instruction. Avoid foaming and mix gently until the crystals have completely dissolved. To minimize imprecision caused by pipetting, use small volumes and ensure that pipettors are calibrated. It is recommended to suck more than 10µL when pipetting. It is recommended to use distilled water to prepare reagents and samples. Using contaminated water or container for reagent preparation will influence detection result.
Assay Precision:	 Intra-assay precision (precision within an assay): Three samples of known concentration were tested twenty times on one plate to assess precision. Inter-assay precision (precision between assays): Three samples of known concentration were tested in twenty assays to assess precision. Intra-assay: CV% less than 8% Inter-assay: CV% less than 10%
